<u>ROADS AND STREETS</u>: Cynthia explained that application for a low interest loan (1.62%) from the State has been submitted. Other documents are required and they are being worked on. It could take up to a year before monies are received. If it takes that long, the Community Block Grant may be earmarked for resurfacing Oliver Lane and Dupont Drive. Repairs in the meantime will be sought.

EXPENSES: A motion to accept and authorize payment of the expenses from June 17, 2020 to July 21, 2020 was made by Cynthia Russo, seconded by Dennis Hooper. Motion carried.

FIRE DEPARTMENT REPORT: Jolene reported that the Department responded to 2 calls this past month. A motion to accept the report was made by Dennis Hooper, seconded by Cynthia Russo.

BUILDING AND GROUNDS: Dennis received a quote to take down the dead tree. It was \$1,200.00. He will get another quote.

<u>PLANNING AND ZONING</u>: A motion to accept the written Planning and Zoning report was made by Cynthia Russo, seconded by Dennis Hooper.
